NEE 176 Claim." There is also a 4"x4" Post 4 at the center of each side line.

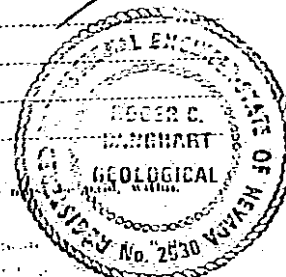
The monumentation and marking of the corners was completed by the 21ST day of JUNE, 1976.
