## CERTIFICATE OF LOCATION

LODE-QUARTZ

THIS IS TO CERTIFY that the NEE 178 lode mining claim

We (or I) claim 1500 linear feet along the course of the mineral-bearing ledge, lode or vein, extending 1486 feet from the location monument in a EASTERLY direction, and 20 feet in a WESTERLY direction, together with 300 feet on each side of the center of the ledge for the entire length of the claim.

The northwest corner is marked by a 4x4 Post 4 feet high, inscribed "NW Corner of the NEE 178 Claim;" the southwest corner is marked by a 4x4 Post 4 feet high, inscribed "SW Corner of the NEE 178 Claim;" the southeast corner is marked by a 4x4 Post 4 feet high, inscribed "SE Corner of the NEE 178 Claim;" the northeast corner is marked by a 4x4 Post 4 feet high, inscribed "NE Corner of the NEE 178 Claim." There is also a 4x4 Post at the center of each side line.

The monumentation and marking of the corners was completed by the 2nd day of July, 1976.  
(must be within 20 days of posting notice of location)


