The northwest corner is marked by a 4" x 4" Post 4 feet high, inscribed "NW Corner
 of the NEE 181 Claim;" the southwest corner is marked by a 4" x 4" Post 4 feet
 high, inscribed "SW Corner of the NEE 181 Claim;" the southeast corner is marked by
 a 4" x 4" Post 4 feet high, inscribed "SE Corner of the NEE 181 Claim;" the
 northeast corner is marked by a 4" x 4" Post 4 feet high, inscribed "NE Corner of the
NEE 181 Claim." There is also a 4" x 4" Post at the center of each side line.

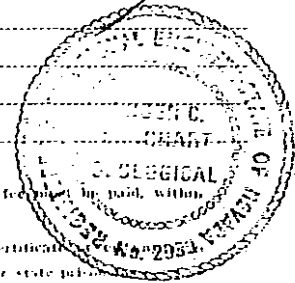
The monumentation and marking of the corners was completed by the 25TH day of JUNE, 1976.

 filing fee has been paid to the County Recorder.
