 each side of the center of the ledge for the entire length of the claim.

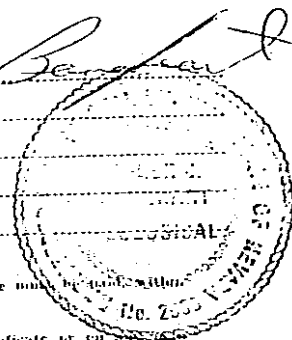
The northwest corner is marked by a **4"x4" Post 4** feet high, inscribed "NW Corner

NEE 195 Claim." There is also a **4"x4" Post** at the center of each side line.

The monumentation and marking of the corners was completed by the **20th** day of **JUNE**, 19**76**.
