CERTIFICATE OF LOCATION

THIS IS TO CERTIFY that the NEE 196 lode mining claim

 NEVADA, in Section 22, Township 26 N., Range 48 E.

We for I) claim 1500 linear feet along the course of the mineral-bearing ledge, lode or
 vein, extending 1480 feet from the location monument in a EASTERN direction,
 and 20 feet in a WESTERN direction, together with 300 feet on
 each side of the center of the ledge for the entire length of the claim.

The northwest corner is marked by a 4"x4" Post 4 feet high, inscribed "NW Corner
 of the NEE 196 Claim;" the southwest corner is marked by a 4"x4" Post 4 feet
 high, inscribed "SW Corner of the NEE 196 Claim;" the southeast corner is marked by
 a 4"x4" Post 4 feet high, inscribed "SE Corner of the NEE 196 Claim;" the
 northeast corner is marked by a 4"x4" Post 4 feet high, inscribed "NE Corner of the
 NEE 196 Claim." There is also a 4"x4" Post at the center of each side line.

The monumentation and marking of the corners was completed by the 21st day of June, 1976.
 (must be within 20 days of posting notice of location)


The location work consisted of making a claim map as provided in NRS 517.040. Two copies of this

 filing fee has been paid to the County Recorder.

Note 1: Two copies of this certificate and two copies of the claim map must be filed, and the \$15 filing fee must be paid, within 30 days after the date of posting Notice of Location.

Note 2: Every person who willfully and knowingly makes a false material statement on the location certificate or map required by the chapter shall be guilty of a felony, and upon conviction thereof shall be imprisoned in the state prison for more than 3 years but not more than 10 years." NRS 475.040. This note is part of the location certificate.
