NEE 198 Claim." There is also a 4" x 4" post at the center of each side line.

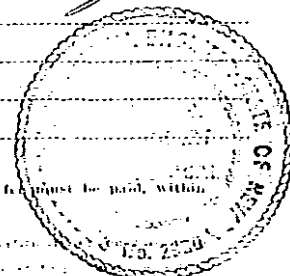
The monumentation and marking of the corners was completed by the 2nd day of July, 1976.
