 each side of the center of the ledge for the entire length of the claim.

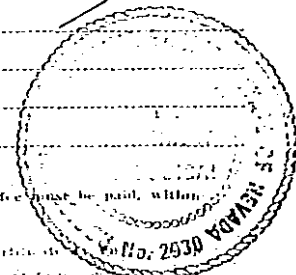
The northwest corner is marked by a 4"x4" Post 4 feet high, inscribed "NW Corner

 high, inscribed "SW Corner of the NEE 202 Claim;" the southeast corner is marked by  
 a 4"x4" Post 4 feet high, inscribed "SE Corner of the NEE 202 Claim;" the  
 northeast corner is marked by a 4"x4" Post 4 feet high, inscribed "NE Corner of the  
NEE 202 Claim." There is also a 4"x4" Post at the center of each side line.

The monumentation and marking of the corners was completed by the 24<sup>th</sup> day of JUN, 1976.  
 (must be within 90 days of posting notice of location)

The location work consisted of making a claim map as provided in NRS 517.040. Two copies of this  
 claim map have been filed with the EUREKA County Recorder, and the \$15.00 lode claim  
 filing fee has been paid to the County Recorder.
