Work for 1) claim 1500 linear feet along the course of the mineral-bearing ledge, lode or
vein, extending 20 feet from the location monument in a EASTERNLY direction,
and 1480 feet in a WESTERNLY direction, together with 300 feet on
each side of the center of the ledge for the entire length of the claim.

The northwest corner is marked by a 4"x4" Post 4 feet high, inscribed "NW Corner
of the NEE 203 Claim;" the southwest corner is marked by a 4"x4" Post 4 feet
high, inscribed "SW Corner of the NEE 203 Claim;" the southeast corner is marked by
a 4"x4" Post 4 feet high, inscribed "SE Corner of the NEE 203 Claim;" the
northeast corner is marked by a 4"x4" Post 4 feet high, inscribed "NE Corner of the
NEE 203 Claim." There is also a 4"x4" Post at the center of each side line.

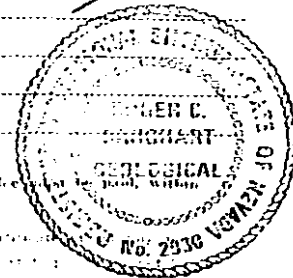
The monumentation and marking of the corners was completed by the 21ST day of JUNE, 1976.
(must be within 30 days of posting notice of location)

The location work consisted of making a claim map as provided in NRS 517.040. Two copies of this
claim map have been filed with the EUREKA County Recorder, and the \$15.00 lode claim
filing fee has been paid to the County Recorder.

Note 2: Every person who willfully and knowingly makes false material statement on the location certificate or on the claim map, or who willfully and knowingly falsifies the location certificate or the claim map, shall be guilty of a felony, and upon conviction thereof shall be punished by imprisonment in the State Prison for not less than one year nor more than five years.
