NEE 212 Claim." There is also a 4" x 4" Post at the center of each side line.

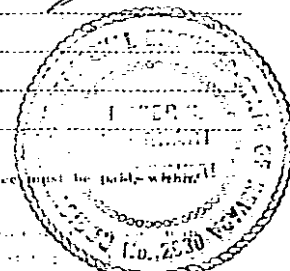
The monumentation and marking of the corners was completed by the 19TH day of JUNE, 1976.
