 high, inscribed "SW Corner of the **NEE 214** Claim;" the southeast corner is marked by
 a **4"x4" Post 4** feet high, inscribed "SE Corner of the **NEE 214** Claim;" the
 northeast corner is marked by a **4"x4" Post 4** feet high, inscribed "NE Corner of the
NEE 214 Claim." There is also a **4"x4" Post** at the center of each side line.


The monumentation and marking of the corners was completed by the **2nd** day of **JULY**, 19**76**.
