# CERTIFICATE OF LOCATION

THIS IS TO CERTIFY that the NEE 216 lode mining claim

CORTEZ Mining District, EUREKA County, State of  
NEVADA, in Section 22, Township 26N, Range 48E.

We (or I) claim 1500 linear feet along the course of the mineral-bearing ledge, lode or  
 vein, extending 1480 feet from the location monument in a EASTERLY direction,  
 and 20 feet in a WESTERLY direction, together with 300 feet on  
 each side of the center of the ledge for the entire length of the claim.

The northwest corner is marked by a 4"x4" Post 4 feet high, inscribed "NW Corner  
 of the NEE 216 Claim;" the southwest corner is marked by a 4"x4" Post 4 feet  
 high, inscribed "SW Corner of the NEE 216 Claim;" the southeast corner is marked by  
 a 4"x4" Post 4 feet high, inscribed "SE Corner of the NEE 216 Claim;" the  
 northeast corner is marked by a 4"x4" Post 4 feet high, inscribed "NE Corner of the  
NEE 216 Claim." There is also a 4"x4" Post at the center of each side line.

The monumentation and marking of the corners was completed by the 19<sup>TH</sup> day of JUNE, 1976.  
 (must be within 20 days of posting notice of location)

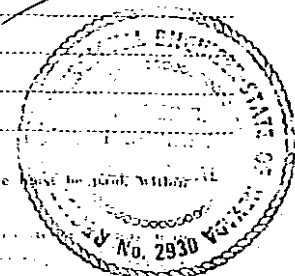
The location work consisted of making a claim map as provided in NRS 517.040. Two copies of this

 filing fee has been paid to the County Recorder.
