THIS IS TO CERTIFY that the NCE 223 lode mining claim
was located by:

on the 30th day of JUNE, 1976, situated in the
CORTEZ Mining District, EUREKA County, State of
NEVADA, in Section 34, Township 20 N, Range 4 E.

We (or I) claim 1500 linear feet along the course of the mineral-bearing ledge, lode or
vein, extending 20 feet from the location monument in a EAST-NORTH direction,
and 1480 feet in a EAST-NORTH direction, together with 300 feet on
each side of the center of the ledge for the entire length of the claim.

The northwest corner is marked by a 4" P.I.E. 4 feet high, inscribed "NW Corner
of the NCE 223 Claim;" the southwest corner is marked by a 4" P.I.E. 4 feet
high, inscribed "SW Corner of the NCE 223 Claim;" the southeast corner is marked by
a 4" x 4" Post 4 feet high, inscribed "SE Corner of the NCE 223 Claim;" the
northeast corner is marked by a 4" x 4" Post 4 feet high, inscribed "NE Corner of the
NCE 223 Claim." There is also a 4" x 4" Post at the center of each side line.

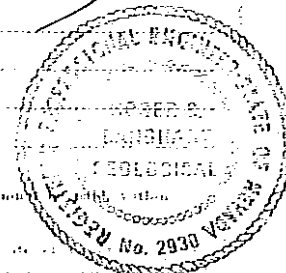
The monumentation and marking of the corners was completed by the 10th day of JULY, 1976.
(must be within 90 days of posting notice of location)

The location work consisted of making a claim map as provided in NRS 517.040. Two copies of this
claim map have been filed with the CORTEZ County Recorder, and the \$15.00 lode claim
filing fee has been paid to the County Recorder.

Note 1: Two copies of this certificate and two copies of the claim map must be filed, and the \$15 filing fee must be paid, within 90 days after the date of posting Notice of Location.

Note 2: "Every person who willfully and knowingly makes a false or fraudulent statement on the location certificate as required by this chapter shall be guilty of a crime, and shall be fined not more than \$10,000 or imprisoned not more than 10 years, or both."

Note 3: All of the above provisions apply to the location of a lode claim.

Note 4: This certificate is void if the claim is not located within the time specified in the above provisions.
