CERTIFICATE OF LOCATION

We (or I) claim **1500** linear feet along the course of the mineral-bearing ledge, lode or vein, extending **30** feet from the location monument in a **EASTERN** direction, and **1486** feet in a **WESTERN** direction, together with **366** feet on each side of the center of the ledge for the entire length of the claim.

The northwest corner is marked by a **4" PIPE 4** feet high, inscribed "NW Corner of the **NCE 229** Claim;" the southwest corner is marked by a **4" PIPE 4** feet high, inscribed "SW Corner of the **NCE 229** Claim;" the southeast corner is marked by a **4" x 4" Post 4** feet high, inscribed "SE Corner of the **NCE 229** Claim;" the northeast corner is marked by a **4" x 4" Post 4** feet high, inscribed "NE Corner of the **NCE 229** Claim." There is also a **4" x 4" Post** at the center of each side line.

The monumentation and marking of the corners was completed by the **16th** day of **JULY**, 1976.

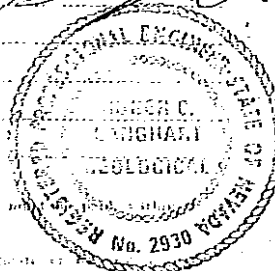
