We (or I) claim 1500 linear feet along the course of the mineral-bearing ledge, lode or

 each side of the center of the ledge for the entire length of the claim.

The northwest corner is marked by a 4"x4" post 4 feet high, inscribed "NW Corner
 of the NEE 240 Claim;" the southwest corner is marked by a 4"x4" post 4 feet
 high, inscribed "SW Corner of the NEE 240 Claim;" the southeast corner is marked by
 a 4"x4" post 4 feet high, inscribed "SE Corner of the NEE 240 Claim;" the
 northeast corner is marked by a 4"x4" post 4 feet high, inscribed "NE Corner of the
NEE 240 Claim." There is also a 4"x4" post at the center of each side line.

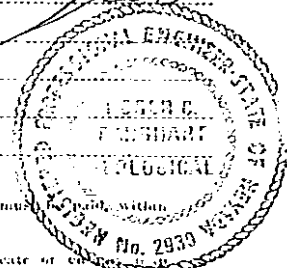
The monumentation and marking of the corners was completed by the 30TH day of JUNE, 1976
