CERTIFICATE OF LOCATION**LODE-QUARTZ**

THIS IS TO CERTIFY that the **N.E.^{1/4} 240** lode mining claim

Central Mining District, EUREKA, County, State of
NEVADA, in Section **503 35**, Township **27 N.**, Range **48 E.**

We (or I) claim **1500** linear feet along the course of the mineral-bearing ledge, lode or vein, extending **1480** feet from the location monument in a **EASTERLY** direction, and **20** feet in a **WESTERLY** direction, together with **300** feet on each side of the center of the ledge for the entire length of the claim.

The northwest corner is marked by a **4x4" Post** **4** feet high, inscribed "NW Corner of the **N.E.^{1/4} 240** Claim;" the southwest corner is marked by a **4x4" Post** **4** feet high, inscribed "SW Corner of the **N.E.^{1/4} 240** Claim;" the southeast corner is marked by a **4x4" Post** **4** feet high, inscribed "SE Corner of the **N.E.^{1/4} 240** Claim;" the northeast corner is marked by a **4x4" Post** **4** feet high, inscribed "NE Corner of the **N.E.^{1/4} 240** Claim." There is also a **4x4" Post** at the center of each side line.

The monumentation and marking of the corners was completed by the **30th** day of **JUNE**, 1976
(must be within 20 days of posting notice of location)

The location work consisted of making a claim map as provided in NRS 517.040. Two copies of this claim map have been filed with the **EUREKA** County Recorder, and the \$15.00 lode claim filing fee has been paid to the County Recorder.

Note 1: Two copies of this certificate and two copies of the claim map must be filed, and the \$15 filing fee must be paid, within 20 days after the date of posting Notice of Location.

Note 2: "Every person who willfully and knowingly makes a false material statement on the location certificate or claim map required by the chapter shall be guilty of a felony, and upon conviction thereof shall be imprisoned in the state penitentiary for not less than 3 years nor more than 10 years." NRS 517.040, 517.041.
