THIS IS TO CERTIFY that the NEE 241 lode mining claim

on the 29<sup>TH</sup> day of JUNE, 1976, situated in the  
CORTEZ Mining District, EUREKA County, State of  
NEVADA, in Section 34 35, Township 27 N, Range 48 E.

We (or I) claim 1500 linear feet along the course of the mineral-bearing ledge, lode or  
vein, extending 20 feet from the location monument in a EASTERNLY direction,  
and 1486 feet in a WESTERNLY direction, together with 300 feet on  
each side of the center of the ledge for the entire length of the claim.

The northwest corner is marked by a 4"x4" Post 4 feet high, inscribed "NW Corner  
of the NEE 241 Claim;" the southwest corner is marked by a 4"x4" Post 4 feet  
high, inscribed "SW Corner of the NEE 241 Claim;" the southeast corner is marked by  
a 4"x4" Post 4 feet high, inscribed "SE Corner of the NEE 241 Claim;" the  
northeast corner is marked by a 4"x4" Post 4 feet high, inscribed "NE Corner of the  
NEE 241 Claim." There is also a 4"x4" Post at the center of each side line.

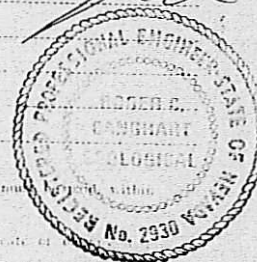
The monumentation and marking of the corners was completed by the 2<sup>ND</sup> day of JULY, 1976.  
(must be within 30 days of posting notice of location)

The location work consisted of making a claim map as provided in NRS 517.040. Two copies of this  
claim map have been filed with the EUREKA County Recorder, and the \$15.00 lode claim  
filing fee has been paid to the County Recorder.

Note 1: Two copies of this certificate and two copies of the claim map must be filed, and the \$15 filing fee must be paid, within  
50 days after the date of posting Notice of Location.

Note 2: "Every person who willfully and knowingly makes a false material statement on the location certificate or  
required by this chapter shall be guilty of a felony and upon conviction thereof shall be fined not less than \$10,000 nor more than \$50,000 or imprisoned not less than 1 year nor more than 5 years, or both."

Note 3: No person shall locate a claim on public lands until the public lands have been surveyed.
