CERTIFICATE OF LOCATION

LODE-QUARTZ

THIS IS TO CERTIFY that the NEE 245 lode mining claim

CORTEZ Mining District, EUREKA County, State of
NEVADA, in Section 32, Township 26 N, Range 48 E.

We (or I) claim 1500 linear feet along the course of the mineral-bearing ledge, lode or
vein, extending 20 feet from the location monument in a EASTERN direction,
and 1480 feet in a WESTERN direction, together with 300 feet on
each side of the center of the ledge for the entire length of the claim.

The northwest corner is marked by a 4" PIPE 4 feet high, inscribed "NW Corner
of the NEE 245 Claim;" the southwest corner is marked by a 4" PIPE 4 feet
high, inscribed "SW Corner of the NEE 245 Claim;" the southeast corner is marked by
a 4"x4" Post 4 feet high, inscribed "SE Corner of the NEE 245 Claim;" the
northeast corner is marked by a 4"x4" Post 4 feet high, inscribed "NE Corner of the
NEE 245 Claim." There is also a 4"x4" Post at the center of each side line.


The monumentation and marking of the corners was completed by the 8th day of July, 1976.
(must be within 30 days of posting notice of location)

The location work consisted of making a claim map as provided in NRS 517.040. Two copies of this
claim map have been filed with the EUREKA County Recorder, and the \$15.00 lode claim
filing fee has been paid to the County Recorder.

required by this chapter shall be guilty of a misdemeanor and shall be punished by imprisonment in the county jail for a term of
not more than 5 years nor more than 1000 dollars."

Note 3: "The claimant shall be responsible for the maintenance of the location monumentation and marking of the corners."
