# CERTIFICATE OF LOCATION

LODE-QUARTZ

THIS IS TO CERTIFY that the NEE 257 lode mining claim was located by:

on the 6<sup>th</sup> day of JULY, 1976, situated in the CORTEZ Mining District, EUREKA County, State of NEVADA, in Section 3, Township 26N, Range 48E.

We (or I) claim 1500 linear feet along the course of the mineral-bearing ledge, lode or vein, extending 25 feet from the location monument in a EASTERNLY direction, and 1475 feet in a WESTERNLY direction, together with 300 feet on each side of the center of the ledge for the entire length of the claim.

The northwest corner is marked by a 4" x 4" post 4 feet high, inscribed "NW Corner of the NEE 257 Claim;" the southwest corner is marked by a 4" x 4" post 4 feet high, inscribed "SW Corner of the NEE 257 Claim;" the southeast corner is marked by a 4" x 4" post 4 feet high, inscribed "SE Corner of the NEE 257 Claim;" the northeast corner is marked by a 4" x 4" post 4 feet high, inscribed "NE Corner of the NEE 257 Claim." There is also a 4" x 4" post at the center of each side line.

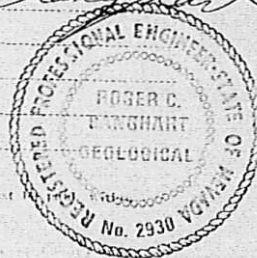
The monumentation and marking of the corners was completed by the 16<sup>th</sup> day of JULY, 1976.  
(must be within 30 days of posting notice of location)

The location work consisted of making a claim map as provided in NRS 517.040. Two copies of this claim map have been filed with the EUREKA County Recorder, and the \$15.00 lode claim filing fee has been paid to the County Recorder.
