

Certificate of Location of Lode Mining Claim

Located about 3/4 of a mile northwest of U.S.L.M. 228. The east end line is common with the west end line, of Aspen No. 59 claim. The south side line is common with the north side line of Aspen No. 61 claim.

The claim is 1500 feet long and 600 feet wide, and 500 ~~50~~ feet is claimed in a easterly direction and 1450 ~~west~~ westerly direction from the location monument, at which the Notice of Location is posted, lengthwise of the claim, together with 300 feet in width on each side of the center of the claim. The general course of the lode deposit and premises is from the East North to the South West.

The location and number of each corner of this claim is shown on the claim map that is filed herewith. On the ground, each corner of the claim is marked with its appropriate number by jar with notice, nailed to post.

The monumentation and marking of the corners was completed by the 14th day of May, 1976.

The location work consisted of making a claim map as provided in NRS 517.040. Two copies of this claim map have been filed with the Eureka County Recorder, and the \$15.00 lode claim filing fee has been paid to the County Recorder.
