(2) That during the months of May and August of 1976, there was expended, and/or labor or improvements made upon and for the benefit of the foregoing mining claims in an amount in excess of SEVEN HUNDRED DOLLARS (\$700); AND,

(3) The character of expenditures and/or labor and/or improvements consisted of road maintenance and repairs, sampling and assaying and claim maintenance amounting in excess of \$359, and a geophysical magnetic survey amount to \$558, for which a summary report follows:

(a) A map is attached to this Affidavit, marked Exhibit "A", which shows the area encompassing the surface magnetic geophysical survey with relation to the claims and the location and discovery monuments.

(b) The nature of the survey was to determine the magnetic effects at the surface and the extent of the survey is shown on Exhibit "A" and was conducted at an expense of \$558.

(c) The basic findings were that no magnetic anomalies of any consequence were encountered in the area surveyed.

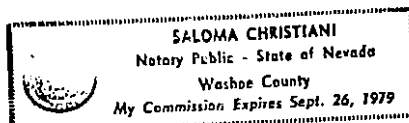
