a group, and for the purpose of facilitating the discovery and extraction of minerals in or on said claims and property.

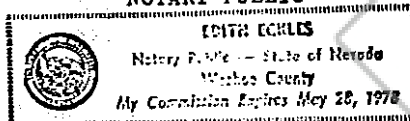
