That the said parties of the first part, for and in consideration of the sum of TEN DOLLARS (\$10.00), lawful money of the United States, to them in hand paid by the said parties of the second part, the receipt whereof is hereby acknowledged, do by these presents GRANT, bargain, sell and convey unto the said parties of the second part, with right of survivorship and to the survivor of them, as joint tenants, and not as tenants in common, their assigns, and to the heirs and assigns of the survivor thereof, all that certain lot, piece or parcel of land situate in the County of Eureka, State of Nevada, more particularly described as follows, to-wit:

East 1/2 of Section 33, Township 22 North, Range 54 East, M.D.B. & M.

Together with all vested and accrued water rights under Permit Nos. 13649 and 29895, 29896

Grantors do not sell but reserve for themselves and their assigns, and to the heirs and assigns of the survivor thereof, all the oil and gas in and under the lands described herein, with the perpetual right of ingress and egress to and from said land for the purpose of drilling and exploring and in every way operating for such oil and gas and removing the same.

Together with all and singular the tenements, hereditaments and appurtenances thereunto belonging, or in anywise appertaining, and the reversion and reversions, remainder and remainders, rents, issues and profits thereof.

TO HAVE AND TO HOLD, all and singular the said premises, together with the appurtenances, unto the said parties of the second part, with right of survivorship and to the survivor of them, as joint tenants, and not as tenants in common, their assigns, and to the heirs and assigns of the survivor, forever.

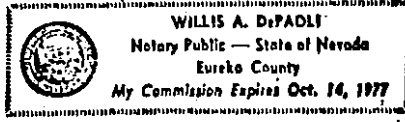
