GRANT, BARGAIN AND SALE DEED

THIS INDENTURE, made and entered into this 30th day of October, H 1974, by and between RANCERS EQUIPMENT AND SUPPLY COMPANY, INC., a Nevada corporation, P.O. TOGETHER with all buildings and improvements situate thereon.
