12 NOW COMES the petitioner, MARY DIEHL, and presents the
 13 last will and testament of said decedent and proves to the
 14 satisfaction of the court that the time for hearing the petition
 15 for the probate of the will was by the clerk duly set for hearing
 16 on the 24th day of September, 1976, and that notice of said hear-
 17 ing has been given, and no person appearing to contest the said
 18 petition, the court proceeds to hear the evidence, and thereupon
 19 finds the facts alleged therein to be true, and that said petition
 20 ought to be granted, and it appearing that the total value of the
 21 estate of said decedent over and above all liens and encumbrances
 22 of record at the date of death of decedent, does not exceed
 23 \$10,000.00, that the same be set aside to the heirs of said
 24 decedent in accordance with the last will and testament of JOE
 25 OTEGUI, deceased, that all expenses of last illness and funeral,
 26 together with all debts of decedent, have been fully paid,
 27 including expenses of administration.

28 IT IS, THEREFORE, ORDERED, ADJUDGED AND DECREED by the

 30 be and the same is hereby assigned to, and that the title thereof

1 shall vest absolutely in MARY DIEHL and FRANK OTEGUI, the children
2 of said decedent. That said property consists of money in the
3 First National Bank of Nevada, Eureka Branch, in the sum of
4 \$ 2,278.67, together with the following described real
5 property, to-wit:

7 Town of Eureka, County of Eureka, State of
8 Nevada, as the same more fully appear on the
9 Official Map now on file in the office of the
County Recorder, Eureka County, Nevada.
