1. That portion of Exhibit "A" included in Paragraph 1 of said lease, describing the land included in and made subject to said lease which reads:

"....Section 29.... NW\SE\, NE\NE\SE\, S\SE\...."

is hereby amended to read as follows:

"....Section 29.... NW\SE\, S\SE\..."

2. That portion of Paragraph 1 of said lease which reads:

"....containing 530 acres of land more or less....

is hereby amended to read as follows:

"....containing 520 acres of land more or less...."

3. That portion of Paragraph 4 of said lease which reads:

"....in advance, as rental, the sum of Five Hundred Thirty and No/100 Dollars (\$530.00)...."

is hereby amended to read as follows:

"....in advance, as rental, the sum of Five Hundred Twenty and No/100 Dollars (\$520.00)...."

4. As herein amended, said lease shall remain in full force and effect.

The provisions of this agreement shall be binding upon and shall inure to the benefit of the respective successors and assigns of the parties hereto.
