14 FARMS, INC., having failed to answer within the time required by
15 law and the default of said Defendant having been duly entered
16 for failure to appear and answer and it further appearing that
17 Plaintiff's action is based upon contract and is for the recovery
18 of money or damages only; it further appearing that service of
19 Summons was made upon LEO J. PUCCINELLI, Resident Agent for the
20 Defendant, DIVADA FARMS, INC., on March 16, 1976, and that Defend-
21 ant has failed to appear or otherwise answer the Complaint; that
22 Plaintiff has been compelled to employ counsel and incur costs
23 herein and that the sum of SIX HUNDRED DOLLARS (\$600.00) is a
24 reasonable counsel fee to be awarded to Plaintiff.

25 NOW, THEREFORE, IT IS HEREBY ORDERED that Plaintiff have
