THIS INDENTURE, made and entered into this 23rd day of November, 1976, by and between JOAN SHANGLE, Trustee, in and for EUREKA COUNTY, STATE OF NEVADA, First Party; and DONALD E. MORRISON and ALBERTA J. MORRISON, his wife, of Eureka, Eureka County, Nevada, Second Parties;

W I T N E S S E T H:

That the said First Party, for and in consideration of the sum of TEN DOLLARS (\$10.00), lawful, current money of the United States of America, to her in hand paid by the Second Parties, the receipt whereof is hereby acknowledged, does by these presents grant, bargain, sell, convey, and confirm unto the said Second Parties as joint-tenants with right of survivorship, and not as tenants in common, and to the assigns of the said Second Parties and to the survivor of them, and to the heirs, executors, administrators and assigns of the survivor forever, that certain real property situate, lying and being in the Town of Eureka, County of Eureka, State of Nevada, and more particularly described as follows:

TO HAVE AND TO HOLD, all and singular, the said premises,
together with the appurtenances, privileges, hereditaments, improve-
ments, easements and rights-of-way appertaining, unto the said
Second Parties as joint-tenants with right of survivorship, and not
as tenants in common and to the survivor of them, and to the heirs,
executors, administrators, and assigns of the survivor forever.
