The claim is 1320 feet long and 590 feet wide, and 50 feet is claimed in a N direction and 1270 feet in a S direction from the location monument, at which the Notice of Location is posted, lengthwise of the claim, together with 295 feet in width on each side of the center of the claim. The general course of the lode deposit and premises is from the NORTH to the SOUTH.

The location and number of each corner of this claim is shown on the claim map that is filed herewith. On the ground, each corner of the claim is marked with its appropriate number by METAL TAG UPON 4X4 WOODEN POST
