To all to whom these presents shall come, Greeting:

Witness, a Certificate of the Land Office at Reno, Nevada,

is now deposited in the Bureau of Land Management, whereby it appears that full payment has been made by the claimant, **Paul L. Cannon, assignee by mesne conveyance of Vera Isabelle Hellweg,** according to the provisions of the Act of Congress approved March 3, 1877 (19 Stat. 377), as amended by the Act of March 3, 1891 (26 Stat. 1066), for the following described land:

Now Know Ye, That the United States of America, in consideration of the premises, and in conformity with the several Acts of Congress in such case made and provided, Has Given, and Granted, and by these presents Does Give, and Grant, unto the said claimant, and to the heirs of the said claimant, the tract above described: To Have, and To Hold the same, together with all the rights, privileges, immunities, and appurtenances, of what-over nature, thereto belonging, unto the said claimant, and to the heirs and assigns of the said claimant, forever; subject to any vested and accrued water rights for mining, agricultural, manufacturing, or other purposes, and rights to ditches and reservoirs used in connection with such water rights, as may be recognized and acknowledged by the local customs, laws, and decisions of courts; and there is reserved from the land hereby granted, a right-of-way thereon for ditches or canals constructed by the authority of the United States.

Excepting and reserving, also, to the United States all the oil and gas in the land so patented, and to it or persons authorized by it, the right to prospect for, mine, and remove such deposits from the same upon compliance with the conditions and subject to the provisions and limitations of the Act of July 17, 1914 (38 Stat. 509).
