WITNESSETH:

WHEREAS, ASSIGNOR is the owner of a highway right-of-way and material site rightof-way on federal public lands situated in Eureka County, State of Nevada, more particularly described on Exhibit "A" attached hereto, and

WHEREAS, ASSIGNEE is the owner and operator of Oil and Gas Leases on federal lands which adjoin the rights-of-way owned by ASSIGNOR, and

WHEREAS, ASSIGNEE desires to control all federal oil and gas deposits which may underlie the lands under federal oil and gas lease to ASSIGNEE, including lands lying beneath the rights-of-way owned by ASSIGNOR,

NOW, THEREFORE, in consideration of the premises and of other valuable consideration; the receipt and sufficiency which is hereby acknowledged, ASSIGNOR does hereby assign unto ASSIGNEE any and all preference rights of ASSIGNOR which arise or may hereafter arise pursuant to the Right-of-Way Leasing Act of 1930 (Act of May 21, 1930; U.S. Code §301 et seq.) to bid for and acquire a federal oil and gas lease or leases covering all or any portion of the rights-of-way described on Exhibit "A" hereof.

This Assignment is expressly made subject to the paramount rights of ASSIGNOR to continue in exclusive surface occupancy of the federal rights-of-way granted to and held by ASSIGNOR under the Right-of-Way Act of November 9, 1921 (23 U.S. Code §18), and ASSIGNEE shall not be entitled to occupy any portion of the surface of said rights-of-way for purposes of drilling for or producing oil and/or gas without first obtaining ASSIGNOR'S prior written consent thereto.

This Assignment is further expressly made subject to the following two (2) paragraphs:

ASSIGNEE, GETTY OIL COMPANY, as an express condition of this Assignment, agrees to indemnify and hold harmless and blameless, the ASSIGNOR, its servants, employees, agents and officers free and clear from any and all claims or actions for damage to person or

property (including death) arising out of the exercise of the preference rights granted under this assignment.

ASSIGNEE further agrees to repair and make whole, at its own expense, any and all damage caused to the material sites and/or right-of-way owned and controlled by the NEVADA STATE HIGHWAY DEPARTMENT by exercise of ASSIGNEE'S exploration, drilling or extraction of oil and gas under its lease.
