ORDER VESTING TITLE

SUBJECT TO A LIFE ESTATE

The above-entitled case having come on for hearing before a Jury on the 15th day of April, 1977, and the matter having been settled by all the parties hereto, before the case was submitted to the jury, pursuant to a signed STIPULATION, RELEASE and ACCORD AND SATISFACTION, which the Court finds to be fair and reasonable to all the parties concerned, and good cause appearing,

IT IS ORDERED, ADJUDGED and DECREED that Title to Lot 4 of Block 7 of the Township of Eureka, State of Nevada, be and the same is hereby vested in GEORGE PENOLA and HATTIE SCHAEFFER subject to a rent-free Life Estate therein which is vested in JOHN PENOLA and BESSIE PENOLA during the occupancy of said premises by both or either of them.

IT IS FURTHER ORDERED that George Penola and Hattie Schaeffer are granted an access easement across said premises for the purpose of ingress and egress to and from their adjoining lots.

IT IS FURTHER ORDERED that John Penola and Bessie Penola be granted the use of Archie Allison's house as a storage facility until October 1, 1977, together with an access easement thereto.

IT IS FURTHER ORDERED that all claims and demands by any of the signatories to the March 17, 1977, Stipulation, Release, Accord and Satisfaction Agreement, and all the parties hereto, one against the other, be and the same are hereby cancelled and held for naught.
