GRANT DEED TO JOINT TENANTS

FOR THE CONSIDERATION of TEN DOLLARS (\$10.00), and other valuable consideration, the receipt of which is acknowledged, CHARLES F. JANACEK and MAE JANACEK, his wife, herein referred to as Grantors, do hereby grant, bargain and sell to DAVID M. GLENN and VICTORIA J. GLENN, his wife, whose address is 4215 Yaleton, Covina, California 91722, herein referred to as Grantees, as joint tenants with right of survivorship and not as tenants in common, and their assigns, and the heirs and assigns of the survivor, forever, the property and premises located in the County of Eureka, State of Nevada, described as follows:

Township 30 North, Range 49 East, M.D.B. & M.

Section 15: E 1/2 of the SE 1/4

EXCEPTING an easement on all boundaries thereof 30 feet in width for utility and public road purposes.

SUBJECT TO a reservation of 90% of all coal, oil, gas and other minerals, including the right of entry, as reserved in that certain deed from Strathearn Cattle Company, et al. to Mae Nichols dated May 2, 1959.

FURTHER SUBJECT TO all reservation, restrictions, exceptions, covenants, easements and rights-of-way of record, and current taxes.

TOGETHER WITH all buildings and improvements thereon.

TOGETHER WITH the tenements, hereditaments and appurtenances thereunto belonging or in anywise appertaining, and the reversion and reversions, remainder and remainders, rents, issues and profits thereof.

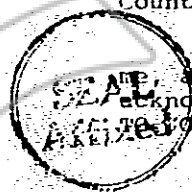
