IN WITNESS WHEREOF, the Sellers have executed this Bill of Sale the 14<sup>th</sup> day of March, 1977.

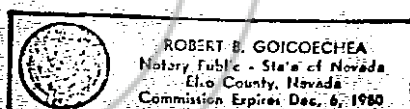
