W I T N E S S E T H: That the said party of the first part, for and in consideration of the sum of Ten Dollars (\$10.00), in lawful money of the United States of America, and other valuable consideration, to him in hand paid by the said parties of the second part, the receipt whereof is hereby acknowledged, does by these presents grant, bargain, sell, convey and confirm unto the said parties of the second part, their heirs and assigns forever, as joint tenants and not as tenants in common, and with full rights of survivorship, all of his interest of, in and to that certain real property, the same being a one-half ($\frac{1}{2}$) interest, situate, lying and being in the County of Eureka, State of Nevada, and more particularly described as follows, to-wit:

TOWNSHIP 32 NORTH, RANGE 50 EAST, M.D.B. & M.

Section 14: South Half ($\frac{1}{2}$)

Excepting therefrom: land heretofore conveyed to the State of Nevada for highway purposes.

TOGETHER WITH all and singular, the tenements, hereditaments and appurtenances thereunto belonging, or in anywise appertaining, and the reversion and reversions, remainder and remainders, rents, issues and profits thereof.

TO HAVE AND TO HOLD, all and singular, together with the appurtenances, the undivided one-half ($\frac{1}{2}$) interest of the party of the first part, unto the parties of the second part, their heirs and assigns forever, as joint tenants and not as tenants in


