11 ORDER SETTLING FIRST ACCOUNT OF EXECUTOR AND ORDER
12 FOR PARTIAL DISTRIBUTION

13
14 ROSS P. EARDLEY, as the Executor of the Last Will and
15 Testament of LOUIS CLARKSON, Deceased, having filed herein his
16 First Account and his Petition to Settle First Account and
17 Petition for Partial Distribution, and said Account and
18 Petition having duly and regularly come on for hearing on the
19 25th day of May, 1977, and having been heard on said date, and
20 the Petitioner being present in Court; and

21 IT APPEARING that due notice of the hearing of said
22 First Account and said Petition were given as required by law
23 and as required by the Order of this Court, and proof having been
24 made to the satisfaction of the Court, the Court finds that all
25 of the allegations of the Petition are true, and that said
26 First Account is in all respects true and correct, and is
27 supported by proper vouchers;

28 IT FURTHER APPEARING to the Court that the assets and
29 property of the Estate have been duly inventoried and appraised
30 as required by law, and that the Executor has duly accounted
31 for all of the said property and that the value of the Estate
32 at the date of the death of the Decedent was \$351,480.85.

1 THE COURT FURTHER FINDS that the First Account of the
2 Executor, which was filed herein on May 13, 1977, and
3 which covers the period from March 15, 1976, to February 28,
4 1977, is in all respects true and correct, and the Court hereby
5 approves and ratifies said account.

6 THE COURT FURTHER FINDS that the time for filing
7 claims in the above Estate has expired, and all Creditor Claims
8 and other known debts and obligations of the Estate, except
9 the Creditor Claim of LORRAINE PETERSON, have been paid in full
10 and duly accounted for in the First Account of the Executor.
11 The Executor, as of the date of said accounting, had cash on
12 hand, in the sum of \$45,748.91.

13 THE COURT FURTHER FINDS that the Federal Estate Tax
14 has been prepared, paid, and accepted by the Internal Revenue
15 Service; that the individual 1975 Income Tax of Louis Clarkson
16 has been prepared and paid; and that the 1976 Estate Income
17 Tax Return has been prepared and paid.

18 The Court finds that the Estate is not yet ready to be
19 closed, pending the settlement of the CLARKSON-KROM PARTNERSHIP
20 and the payment of the LORRAINE PETERSON Creditor Claim.
21 Before said Creditor Claim can be paid, it is necessary that the
22 former partnership assets be sold by the surviving partner and
23 that the Contracts of Sale made by LOUIS CLARKSON during his life
24 be paid in full.

25 The Court finds, however, that there are certain assets
26 of the Estate which can be distributed at the present time,
27 as follows:

28 86 Shares of Stock in the Texas Company
29 291 Shares of Stock in Texaco, Inc.
30 200 Shares of Stock in Western Industries

31 Gas, Oil and Mineral rights appurtenant to the

12 The Court finds that the other assets of the Estate
13 should remain in the Estate pending the further order of the
14 Court, the settlement of the KROM-CLARKSON PARTNERSHIP
15 obligations, and the payment of the LORRAINE PETERSON Creditor
16 Claim.

17 The Court finds that under the terms of Paragraph "FIFTH"
18 of the Last Will and Testament of the Decedent, distribution
19 of the Estate should be made as follows:

20 ANNA C. DUNN, an undivided one-fifth interest or
21 20%.

22 PHOEBE I. RICKETTS, an undivided one-fifth interest
23 or 20%.

24 The remaining three-fifths undivided interest to
25 be distributed equally to the following nieces and
26 nephews of the Decedent, the share of each said
27 niece or nephew being 4.615%:

33 The Court finds that all of said persons are alive and have
34 capacity to receive distribution.

1 The Court finds that ROSS P. EARDLEY has advanced costs
2 of administration in the sum of \$280.58, and that he should
3 be reimbursed from the Estate for said costs.

4 NOW THEREFORE, good cause appearing, it is hereby
5 ORDERED, ADJUDGED AND DECREED that the Notice of Hearing of
6 the First Account and Petition to Settle First Account and
7 Petition for Partial Distribution was given in the manner and
8 form required by law and by the order of this Court; and it is
9 further Ordered, Adjudged and Decreed that the First Account
10 of the Executor, as filed herein, be, and the same hereby is,
11 settled, approved and allowed.

12 IT IS FURTHER ORDERED, ADJUDGED AND DECREED that the
