ORDER SETTLING FIRST ACCOUNT OF EXECUTOR AND ORDER FOR PARTIAL DISTRIBUTION

ROSS P. EARDLEY, as the Executor of the Last Will and Testament of LOUIS CLARKSON, Deceased, having filed herein his First Account and his Petition to Settle First Account and Petition for Partial Distribution, and said Account and Petition having duly and regularly come on for hearing on the 25th day of May, 1977, and having been heard on said date, and the Petitioner being present in Court; and

IT APPEARING that due notice of the hearing of said

First Account and said Petition were given as required by law

and as required by the Order of this Court, and proof having been

made to the satisfaction of the Court, the Court finds that all

of the allegations of the Petition are true, and that said

First Account is in all respects true and correct, and is

supported by proper vouchers;

IT FURTHER APPEARING to the Court that the assets and property of the Estate have been duly inventoried and appraised as required by law, and that the Executor has duly accounted for all of the said property and that the value of the Estate at the date of the death of the Decedent was \$351,480.85.

THE COURT FURTHER FINDS that the First Account of the Executor, which was filed herein on May 13, 1977, and which covers the period from March 15, 1976, to February 28, 1977, is in all respects true and correct, and the Court hereby approves and ratifies said account.

THE COURT FURTHER FINDS that the time for filing claims in the above Estate has expired, and all Creditor Claims and other known debts and obligations of the Estate, except the Creditor Claim of LORRAINE PETERSON, have been paid in full and duly accounted for in the First Account of the Executor. The Executor, as of the date of said accounting, had cash on hand, in the sum of \$45,748.91.

THE COURT FURTHER FINDS that the Federal Estate Tax has been prepared, paid, and accepted by the Internal Revenue Service; that the individual 1975 Income Tax of Louis Clarkson has been prepared and paid; and that the 1976 Estate Income Tax Return has been prepared and paid.

The Court finds that the Estate is not yet ready to be closed, pending the settlement of the CLARKSON-KROM PARTNERSHIP and the payment of the LORRAINE PETERSON Creditor Claim.

Before said Creditor Claim can be paid, it is necessary that the former partnership assets be sold by the surviving partner and that the Contracts of Sale made by LOUIS CLARKSON during his life be paid in full.

The Court finds, however, that there are certain assets of the Estate which can be distributed at the present time, as follows:
