

# Certificate of Location of Lode Mining Claim

TO ALL WHOM IT MAY CONCERN:

The undersigned hereby certifies (certify) that he (she, they) has (have) located the Silverado #6 Lode Mining Claim in Section 14 Township 18N Range 53E in the Eureka Mining District, in Eureka County, in the State of Nevada, on the 27 day of Mar, 1977.

The claim is 1500 feet long and 600 feet wide, and 10 feet is claimed in a northerly direction and 1490 feet in a southerly direction from the location monument, at which the Notice of Location is posted, lengthwise of the claim, together with 300 feet in width on each side of the center of the claim. The general course of the lode deposit and premises is from the southerly to the northerly.

The location and number of each corner of this claim is shown on the claim map that is filed herewith. On the ground, each corner of the claim is marked with its appropriate number by lumber pencil.

The monumentation and marking of the corners was completed by the 15 day of Apr, 1977. (Must be within 20 days of posting notice of location)

The location work consisted of making a claim map as provided in NRS 517.040. Two copies of this claim map have been filed with the Eureka County Recorder, and the \$15.00 lode claim filing fee has been paid to the County Recorder.

NRS 517.300, Subsection 2.
