

Certificate of Location of Lode Mining Claim

The claim is 900 feet long and 100 feet wide and 10 feet distant to a southerly direction and 100 feet in a northerly direction from the location monument at which the Notice of Location is posted, lengthwise of the claim, together with 500 feet on each side of the center of the claim. The general course of the lode dipout and trends is from the northerly to the southerly.

The location and number of each corner of this claim as shown on the claim map that is filed herewith. On the ground, each corner of the claim is marked with its appropriate number by number pencil.
