to the satisfaction of the court that his First and Final Account, Report and

Petition for Distribution herein was rendered and filed on June 8, 1977; that
the notice of the hearing thereof was given in the manner prescribed by law;
that no persons appeared to except to or contest said Account; that said Account

Is true and correct as rendered; that the claims presented against said estate

have been paid, save and except as hereinafter set forth.

It appears to the Court that the above-named Deceased died testate in the City of Elko. County of Elko, State of Nevada, on the 13th day of July, 1975, and that at the time of her death, Decedent was a resident of the City of Carlin, County of Elko, State of Nevada, and left estate consisting of real and personal property within the County of Elko, State of Nevada, and within the urisdiction of this court.

It further appears that the above-named GEORGE A. PACINI was appointed Executor of the estate of the above-named Deceased on November 24, 1975, and duly qualified as such on the same date; that Notice to Creditors has been given in the manner prescribed by law, and that no taxes of inheritance or

otherwise are due or payable on any of the property of the above-named Deceased

It further appears that more than ninety (90) days have elapsed since the appointment of the Executor and more than ninety (90) days have expired since the first publication of liotice to Creditors; that no debts are payable by said estate save and except a reasonable attorney fee of the attorney for the Executor, the costs of administration advanced by him, the estimated costs of closing said estate, together with the fees of the appraisor of said estate, the fees to Alexander Grant & Company for services rendered in the preparation of the estate tax return, reimbursement to the Executor for moneys advanced by him for assessment work on the unpatented mining claims, and the statutory fees and commissions due the Executor for his services rendered in connection with said estate; and that there are no bills, other than as hereinabove set forth, due and payable from said estate.

It further appears that MADONNA CHRISTENSEN and KATHI CHRISTENSEN, two of the devisees and legatees of the above-named Decedent have heretofore assigned all of their right, title and interest in and to any and all of the assets of the above entitled estate to GEORGE A. PACINI, the original of which said assignment has heretofore been filed, and have directed that distribution of their portion of the estate be made directly to him.

It further appears to the Court that said estate is now in a condition to be closed and that there remains nothing further for the Executor to do or perform, save and except to make distribution as provided in the Last Will and Testament of the above-named Decedent to the person entitled thereto.

IT IS THEREFORE ORDERED, ADJUDGED AND DECREED that said account be, and is in all respects, approved, allowed and settled.

IT IS FURTHER ORDERED, ADJUDGED AND DECREED that a reasonable attorney's fee for LEO J. PUCCINELLI, the attorney for the Executor, be, and the same hereby is, fixed by the Court in the sum of \$3,067.77, being the

amount heretofore agreed upon between said attorney and the Executor of said estate, together with the sum of \$109.15, the costs of administration advanced by him; the sum of \$40.00, as the estimated costs of closing said estate, including certified copies and recording charges. That all of said fees and costs shall be paid to said attorney forthwith.

IT IS FURTHER ORDERED, ADJUDGED AND DECREED that GEORGE

A. PACINI is entitled to statutory fees and commission for his services heretofore rendered as the Executor of the above estate which the Court hereby
fixes as the sum of \$1,347.11.

IT IS FURTHER ORDERED, ADJUDGED AND DECREED that the Executor shall pay unto VERNON SCOTT, the appraiser for said estate, the sum of \$40.00. That said fees be paid forthwith.

IT IS FURTHER ORDERED, ADJUDGED AND DECREED that the Executor pay unto ALEXANDER GRANT & COMPANY, for services rendered in the preparation of the estate tex return, the sum of \$1,075.00. That said fees be paid forthwith.

IT IS FURTHER ORDERED, ADJUDGED AND DECREED that the Executor pay unto GEORGE A. PACINI, as reimbursement for moneys advanced by him for assessment work on the unpatented mining claims, the sum of \$7,100.00.

IT IS FURTHER ORDERED, ADJUDGED AND DECREED that all of the following described real and personal property, being the separate property of the above-named Deceased, be distributed to GEORGE A. PACINI in accordance with the provisions of Paragraph FIFTH of the Last Will and Testament of the above-named Deceased and the Assignment executed by MADONNA CHRISTENSEN and KATHI CHRISTENSEN, heretofore filed with the above-entitled court.
