## AMENDMENT TO OIL AND GAS LEASE

THE STATE OF NEVADA X
COUNTIES OF EUREKA X
AND ELKO

KNOW ALL MEN BY THESE PRESENTS:

THAT, WHEREAS, SOUTHERN PACIFIC LAND COMPANY, a California corporation, as Lessor, and M. PEYTON BUCY, as Lessee, have entered into Oil and Gas Lease dated July 15, 1975, recorded in Book 54, pages 334-342 of the Records of Eureka County, and Book 231, pages 127-131 of the Records of Elko County, covering the lands described in the Exhibit "A" attached hereto, which exhibit is hereby incorporated herein and made a part hereof by reference; and

WHEREAS, GETTY OIL COMPANY, a Delaware corporation,
GENERAL CRUDE OIL COMPANY, a Delaware corporation, and AGM
CORPORATION, a Delaware corporation, are the current Lessee of
record of said lease; and

WHEREAS, the current Lessor and Lessee of said lease desire to amend same as hereinafter set forth:

NOW THEREFORE, for and in consideration of the premises and of the sum of Ten and No/100 Dollars (\$10.00) and other good and valuable consideration to the SOUTHERN PACIFIC LAND COMPANY, in hand paid by GETTY OIL COMPANY, GENERAL CRUDE OIL COMPANY, and AGM CORPORATION, the receipt and sufficiency of which is hereby acknowledged, SOUTHERN PACIFIC LAND COMPANY, as Lessor, and GETTY OIL COMPANY, GENERAL CRUDE OIL COMPANY, and AGM CORPORATION, as Lessee, do hereby amend the above described lease as follows, to wit:

 Lease paragraphs 2 and 40 are deleted and there is inserted in lieu thereof the following

provisions: "Subject to the other provisions herein contained, this lease shall be for a term of ten (10) years from July 15, 1975, and as long thereafter as oil, gas or other hydrocarbon is produced in paying quantities from said land hereunder, or as long as operations are prosecuted in accordance with paragraph 4 hereof; provided, however, this lease shall terminate on July 15, 2000, as to all lands covered hereby which are not included in the following, to wit: (1) drilling units as defined in paragraph 3 hereof that are occupied by oil wells producing in paying quantities; (2) 640 acre subdivisions upon which each such subdivision is located a well in the process of being drilled; or (3) 640 acre subdivisions upon which each such subdivision is located a gas well producing in paying quantities."

- 2) Lease paragraph 3(c) is deleted and there is inserted in lieu thereof the following provision: "each 640 acre subdivision upon which there is a producing gas well on the date when rental is payable; or".
- 3) The words and figures "ninety (90) days" found in both the fourth and fifth lines of lease paragraph 4 are deleted and there is inserted in lieu thereof the words and figures "one hundred eighty (180) days".
- 4) The following words are added to paragraph 15, to wit: ". .; provided, however, in event of such discovery this lease shall not be so revived as an oil lease as to the formations in each particular gas producing subdivision which were encountered by the producing gas well on such subdivision. Even though this lease is revived as an oil

lease due to the discovery of oil in paying quantities on the leased premises or within offset distance, as provided in the preceding sentence, rentals shall not be payable for each 640 acre subdivision upon which there is a producing gas well on the date when rental is payable.
