That said claims are contiguous and form a compact group, and that said geophysical survey covered, and tends to the development, of all said claims hereinabove enumerated.

That the geophysical survey conducted on said claims for the assessment period ending September 1, 1977, consisted of the following:

A Scintrex Fluxgate Magnetometer was used to make 1,058 observations of the vertical component of the earth's magnetic field over all of the George Claims. These observations were made along parallel traverses striking approximately N 83° E, separated by distances of 150 and 300 feet, and along an orthogonal traverse striking approximately N 7° W. Magnetic observations along the traverses were made at intervals as small as 25 feet and no larger than 100 feet.

Said geophysical survey was conducted in April and June of 1977.

The actual amount paid for said geophysical survey was \$3,200.00, paid by Mineral Services Incorporated, for the purpose of holding said claims.

That Ross W. Whipple is a graduate geophysicist with over twenty-five years of experience and has been a consultant in mining geophysics for more than fourteen years.

That the basic findings of said geophysical survey were:

The magnetic observations made on the George Claims indicate anomalous concentrations of ferromagnetic material within the claim boundaries and also that transverse faulting occurs in the region of the greatest near-surface accumulations of ferromagnetic material.
