

DECLARATION MADE IN SUPPORT OF PROOF OF LABOR UPON MINING CLAIMS


I, the undersigned declare that geochemical sampling and assaying done as stated for assessment work on the Big Jim and Big Jim Nos. 1 through 31, Cracker Jack, Cracker Jack 1 through 5, Yellow Rose 6 through 21, Polar 1 through 20, Lamira (or Lemira), Badger, Badger 1, Compromise 4 through 7, Junction, Unity 1 and 2, Sunday, Hill Top, Hill Top 1 and 2, Hill top Fractions 1 through 4, Paragon, Paragon 1 through 3, and Paragon Fraction lode mining claims in Sections 2, 10, 11, and 12, Township 35 North, Range 50 East, MDB&M, Lynn District, Eureka County, Nevada, and filed by me at the Office of the County Recorder before the 31st day of August, 1977, consisted of the following detailed program:

Assaying of the samples taken during the previous year for arsenic, resampling of anomalous areas in the "B" zone of the soil, sampling of dumps and diggings and assaying for gold, silver, and arsenic over the entire area of the claims, and collating entire geochemical program for the two years of work.

I declare that the basic findings of the geochemical survey as conducted has been to establish a basic arsenic background for each of the formations of the area, 100 ppm for the Vinini group, 25 ppm for the agglomerates, and 60 ppm for the Roberts Mountain and Popovich groups, and that these basic findings result in recommendations for trenching and drilling on Polar 1, 2, 5, 7, 15, 16, 17, 18, 19, and 20, Compromise 6, Badger, Yellow Rose 12, 13, 14, 21, 9, 10, and 11, Cracker Jack 3, 4, and 5, Big Jim 15, 24, 25, and 30 claims.

I declare that I am a graduate of the California Institute of Technology with the degree of Bachelor of Science in Geology; that I have practised geology continuously since my graduation; that I am familiar with the current technology of geochemistry and have worked in the vicinity of the subject lode claims for a period of four years; that I personally supervised or carried out myself the aforesaid program; and that I am active in professional associations including the Association of Exploration Geochemists and am a Member in good standing of the Association of Professional Engineers, Geologists, and Geophysicists of Alberta, Canada.
