Section 33: All

Together with all buildings and improvements situate thereon.

Together with the tenements, hereditaments and appurtenances thereunto belonging or appertaining, and the reversion and reversions, remainder and remainders, rents, issues and profits thereof.

SUBJECT to all taxes and assessments, reservations, restrictions, conditions, exceptions, regulations, zoning, codes, easements, rights-of-way, ordinances, licenses affecting the property, if any, encroachments, if any, upon any street, highway or other property.

It is specifically intended that this Quitclaim Deed shall reconvey only that interest in and to the above-described property obtained by the Grantor herein by Deed recorded August 5, 1977, in Book 60 of Official Records at page 184, Eureka County, Nevada.
