3 THIS INDENTURE, made and entered into this 22 day of  
4 November, 1977, by and between GRANT EDWARD CRUTCHLEY and  
5 CHARLOTTE ANN CRUTCHLEY, husband and wife of Eureka, Nevada,  
6 First Parties, and EUREKA COUNTY, NEVADA, a political subdivision,  
7 acting by and through the BOARD OF COUNTY COMMISSIONERS of said  
8 EUREKA COUNTY, NEVADA, Second Party.

10 W I T N E S S E T H :

11  
12 That the First Parties, for and in consideration of the  
13 mutual benefits to be derived by both parties, and for the public  
14 good and benefit to be had by the people of Eureka County, and  
15 the State of Nevada, do hereby covenant and agree with second  
16 party as follows, to-wit:

17 That the First Parties in recognition of the public need  
18 for a sewer line, do hereby grant, give, deliver and convey unto  
19 Second Party, an Easement, of the following described parcel of  
20 land, located in Eureka County, Nevada, and to be used strictly,  
21 and for no other purposes than for a sewer line:

22 Commencing at the SE corner of Block 48 of the town  
23 of Eureka, Nevada, 155 feet South 81' 27' West thence  
24 bearing North 8' 33' East across Block 48 to a point  
25 at its junction with Bullion Street in the town of  
Eureka, Nevada.

26 TO HAVE AND TO HOLD UNTO the Second Party, the said parcel  
27 of land to be used for the purposes of a sewer line and for no  
28 other purposes, and in the event of abandonment of said line,  
29 said parcel of land to revert to the First Parties as in its first  
30 and former estate.

3 written.

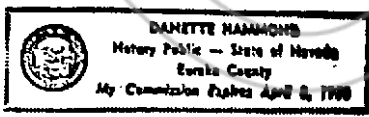
