The Claim is 1200 feet long and 80 feet wide, such that 1195 feet is claimed in a East direction and 25 feet in a West direction from the discovery monument, at which the Notice of Location is posted, lengthwise of the claim, together with 40 feet in width on each side of the discovery monument and centerline of the claim. The general course of the lode deposit and premises is from the East to the West direction.

The definition of the boundaries of the Claim, together with the erection of boundary or corner monuments, and the marking of such monuments was completed by the 11 day of November, 1977.
