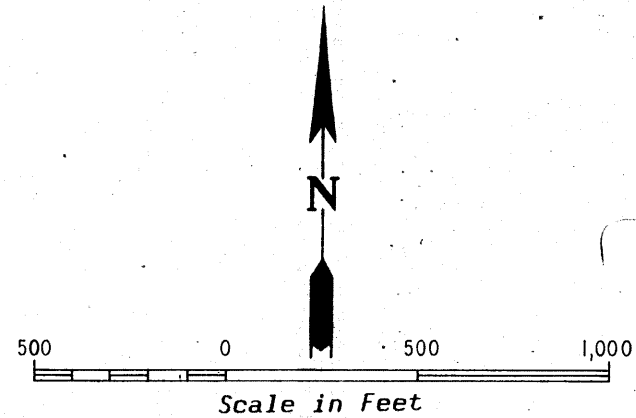

Eureka-Secret Canyon Mining District - Eureka County - Nevada

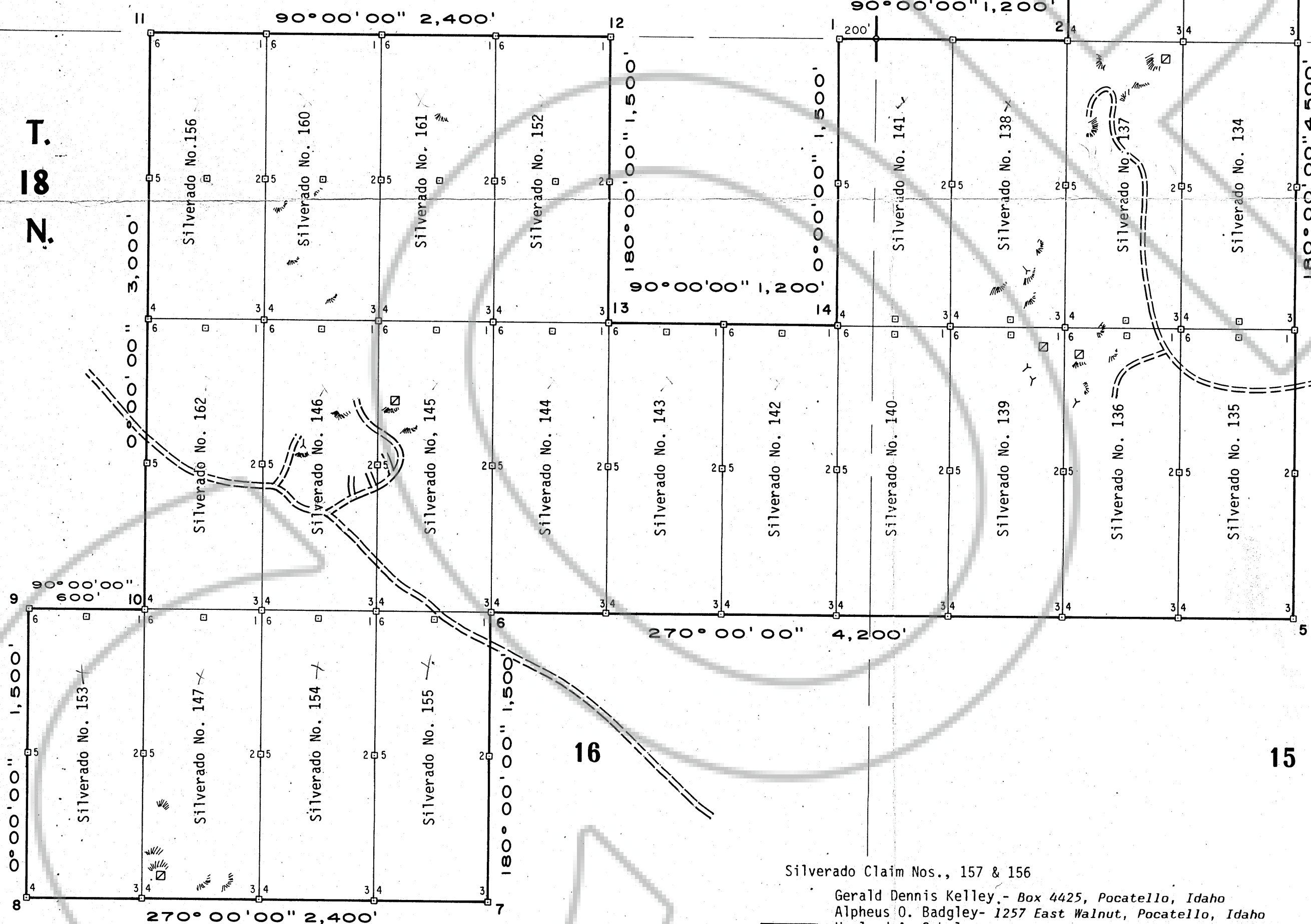
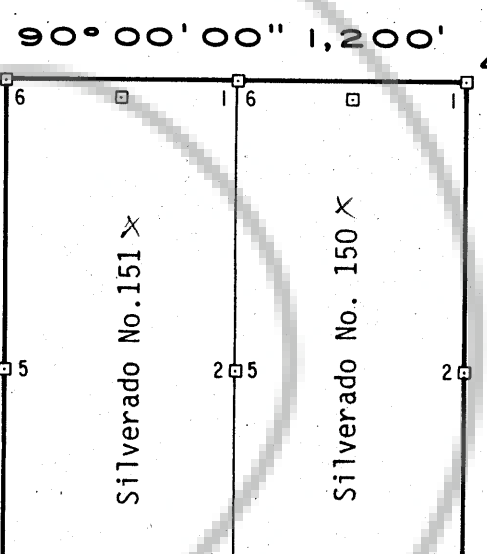
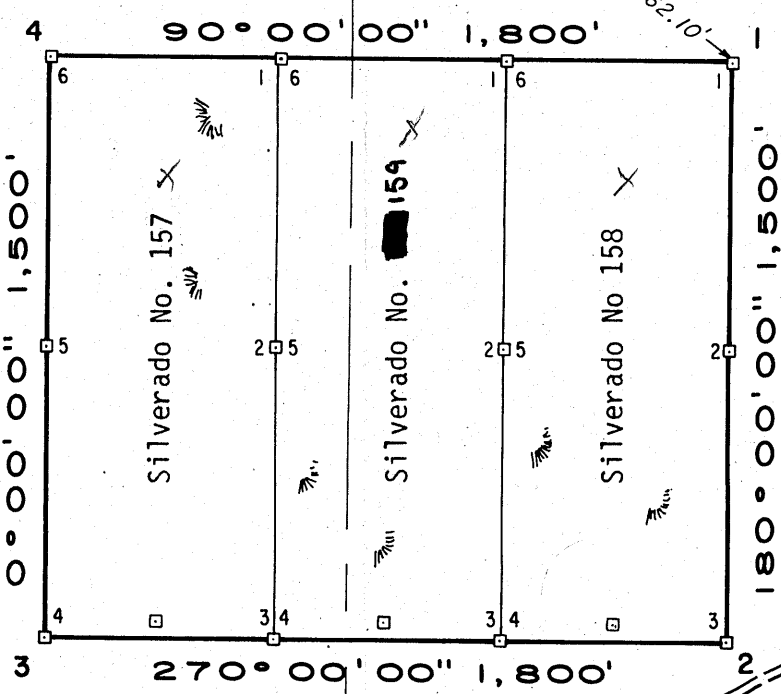
