WARRANTY DEED

The Southeast quarter of the Southwest quarter (Also known as Lot 10) of Section 9, Township 31 North, Range 48 East, M.D.B.M. as per government survey.

SUBJECT TO:

1. Easement of 30 feet along all boundaries for ingress and egress, with power to dedicate.
2. Taxes due not heretofore paid.
3. Covenants, conditions, restrictions, easements rights and/or rights of way record.
4. Ten year Geothermal Resources Lease with short form to Standard Oil Company of California dated the 24th of November, 1975.

TO HAVE AND TO HOLD the said premises, together with the appurtenances, unto the said party of the second part, and to its successors and assigns forever.

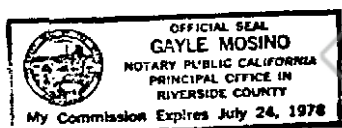
