 to the person or persons legally entitled thereto, but without warranty, the real property described as:

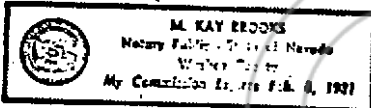

And being a portion of the SW 1/4 of the SE 1/4 of Section 1, T. 31 N., R. 51 E., M. D. B. & M., and more fully described by metes and bounds as follows, to wit:

BEGINNING at a point on the left or westerly right of way line of SR-51, Project HHS-602(11), at a point 152.16 feet left of, and measured radially from, Highway Engineer's Station "S: 743+81.23 P.O.C.; said point of beginning further described as bearing S. 89° 44' 10" E. a distance of 1031.87 feet from the south quarter corner of Section 1, T. 31 N., R. 51 E., M. D. B. & M.; thence N. 26° 32' 28" W., along said right of way line, a distance of 495.95 feet to a point; thence from a tangent which bears S. 32° 57' 01" E. curving to the left with a radius of 1050 feet, through an angle of 16° 33' 56", an arc distance of 303.58 feet to a point; thence S. 49° 30' 57" E. a distance of 334.61 feet to a point on the south section line of said Section 1; thence N. 89° 44' 10" W. along said section line a distance of 232.30 feet to the point of beginning.
