That said WALTER A. PARONI does hereby claim full ownership of said Nellie Lode mining claim and said certificate of location is amended herewith to claim said ownership of said claim as delineated and described as follows:

"PHIL PARONI ESTATE, ANTHONY PARONI, Adm. does hereby certify:

That on the 8th day of August, A.D. 1906, ED BERRYMAN and BEN SIMONSEN discovered within the limits of the Nellie Lode mining claim, as hereinafter particularly described, a lode deposit of mineral in place, bearing gold, silver, copper and other valuable minerals, and thereupon on said day did locate the same as a lode mining claim by posting upon the monument hereinafter described at the point of discovery a notice of said location purporting to comply with the Laws of the United States and of the State of Nevada, and did, within 20 days after the date of said location, define the boundaries of said claim by erecting at each corner and at the center of each side line thereof a monument in the manner prescribed by law and as hereinafter particularly specified:

That thereafter and within 90 days from the date of posting the original Notice of Location upon said claim, to-wit, on the Sept day of 22nd A.D. 1906, said locators recorded said claim by filing for record a location certificate thereof with the District Recorder of Eureka Mining District and with the County Recorder of Eureka County, Nevada, said certificate being found of record in Book H at page 262, Records of Mining Locations in said County

That for the purpose of correcting any and all defects and errors in said original location certificate, and any failure to comply with the requirements of the law before filing the same, and for the purpose of changing the surface boundaries of said claim and of taking in any and all parts of any and all overlapping claims, which have been abandoned, and for the purpose of securing any other and further benefits which may be thereby obtained, and also for the purpose of said undersigned owner does hereby make and file for record this Amended and Additional Certificate of Location of said claim.

That the name of said lode and claim is and it shall be the Nellie.

That the general course of said vein or lode, as nearly as can be ascertained at this time, is Northerly and Southerly and the said undersigned owner claims in length along the course of said lode 1100 linear feet in a Southerly direction and 500 linear feet in a Northerly direction from the point of discovery, together with a width of 300 feet on the Easterly side and 300 feet on the Westerly side of the center of said vein at the surface.
