1. That she is the surviving widow of Anthony L. Frye, also known as Anthony Lawrence Frye, who died at Malaga, Spain, on the 14th day of November, 1977, although he was a domiciliary resident of the town of Sunset, Davis County, Utah.
2. That she is the same and identical person designated and named as one of the grantees and joint tenants with full rights of survivorship in that certain Grant Deed dated on the 27th day of January, 1977, and recorded on the 14th day of February, 1977, in the office of the Eureka County Recorder, State of Nevada, in Book 58 of Official Records, page 282, which said deed transferred and conveyed to the affiant and her then living husband, Anthony L. Frye, as joint tenants with full rights of survivorship, the following described real property situate in Eureka County, State of Nevada, to-wit:

Section 25: SE $\frac{1}{4}$ NE $\frac{1}{4}$

EXCEPTING therefrom an easement on all boundaries hereof 30 feet in width for utility and public road purposes.

That Anthony Lawrence Frye, named in the annexed certified copy of Certificate of Death, issued by the Department of State for the United States, which by this reference is made a part hereof, is the same and identical person named as a joint tenant with the affiant in and to the above described real property.
4. That the affiant, Elizabeth M. Frye, is now the sole owner in fee simple and in sole possession of the above described real property.
5. That neither a Federal estate tax return, nor a Utah State Inheritance tax return, was required to be filed on behalf of the estate of the decedent.
